Presentation from Kashawna White - Manager, Circulation & Branch Services

Circulation & Branch Services is the largest division in the organization. Kashawna supervises, either directly or indirectly, 20-26 people at one time in 3 different locations. Kashawna has worked in making the Branches more efficient and able to provide the same level of service as in Cheyenne. This has made the Branches a more cohesive part of LCLS.
